GALLERY LISTING REQUIREMENTS

- **EXHIBITOR NAME**

- **ARTIST NAMES (PLEASE LIST 1-6 OF YOUR EXHIBITING ARTISTS)**

- **LISTING IMAGE**

A gallery listing image should be one image comprised of 1-6 (no more) artists' images.

Please provide a high-resolution image file that is at least 6" x 4" (the image file can be larger). The image must be 300 dpi (dots per inch) and must be converted to CMYK (Cyan, Magenta, Yellow and Black). Please convert any RGB colors to CMYK. Accepted image files: Tiff, Jpeg, Photoshop, high-resolution PDF.

Please Note: Include your exhibitor name on ALL files. If any of the above requirements are not met, the images may be returned to the exhibitor to make corrections.

- **IMAGE CAPTION**

If submitting a composite image, please include each artist's name. If you are using just one artist's image please provide the following:

- Artist Name
- Image Title

Our designers can create a composite listing image for you (design fee: \$100).
